

One to one Facial Aesthetic Courses with Tim Eldridge

General information

This type of training session is suited to the practitioner who wishes to undertake training in Botox® and/or dermal fillers on a one to one basis with the trainer, in the familiar surroundings of their own practice or at myFACE dentistry and facial aesthetics. The advantage of 1:1 training is the amount of hands on experience you will gain, compared with a group course.

Training in beginners Botox® and Dermal Fillers requires one full day for each. The morning session covers the theory aspects with a presentation from the trainer. The afternoon session gives the opportunity to gain your hands on experience and receive certification.

The training can be delivered in several ways:

- **2 Day Hands on Beginners Course**
This is a two day course for beginners in Botox® and Dermal Fillers. Often this course is run over a weekend to avoid loss of your surgery time, however, we are happy for it to be done during the week if you wish.
- **1 Day Hands on Advanced Course**
This is an advanced Botox® and Dermal Fillers course for delegates who have completed the beginners course. This course can be arranged on a Saturday/Sunday or, with adequate notice, during the week.
- **1 Day Bespoke Hand on Course**
This training is normally undertaken by delegates who have previously attended a beginners and/or advanced Botox® and/or dermal fillers course and would like a refresher.
The day can be tailored to meet your needs. Most delegates feel they could benefit from more hands on experience under the guidance of a trainer, and book a selection of patients in throughout the day for facial aesthetic treatments. Any theoretical aspects, which you are unsure of, will also be covered throughout the day.
Again, this course can be arranged on a Saturday/Sunday or, with adequate notice, during the week.

Terms and conditions

- All patients attending as models must be informed that it is a training programme and informed consent will need to be given on the day.
- Delegates who are unable to bring their own patient/model should inform myFACE training who may be able to provide a suitable patient for the purposes of the course.
- All delegates to observe patient confidentiality whilst on a myFACE training course as they would for a patient in their own practice.
- One to one training days run from 9.00am -5.00pm.
- Delegates completing the beginners course are covered by myFACE training insurance with Hamilton Frazer for the duration of the course only.

- Delegates wishing to complete a bespoke course carrying out the hands on aspect must hold a valid training certificate and appropriate indemnity. If this is not the case, a beginners training course must be undertaken first.
- myFACE training will provide certification of attendance (recognised by Hamilton Frazer) on completion of a short answer test and evaluation.
- myFACE training does not award certification on competence.
- All one to one training sessions are charged at £1,000 per day, plus materials, plus travelling expenses.
- Course fee to be paid in full 2 weeks prior to course date. Material costs and travelling expenses will be invoiced following the course.

For Training courses held at your practice:

- Delegates undertaking the beginners course will be unlikely to provide their own materials, however if you are undertaking advanced or refresher training and wish to provide your own materials please let us know.
- Due to the nature of the training day, it is recommended to book longer appointment times than you usually work to. For Botox® patients a minimum of 30 minutes is required; this should be increased to 45 minutes for dermal filler treatments, and 1 hour if the patient is receiving both.
- You may wish to charge the patients that you treat, either the full or reduced rate, and this is entirely at your own discretion.
- For training courses held at myFACE , all course materials and associated paperwork is provided, along with a buffet lunch
- Cancellation Policy:
A full refund will only be given if delegates give 14 day's notice of cancellation. However, for non-refundable cancellations, delegates will be able to arrange an alternative date. In the unlikely event of myFACE training cancelling the course, we will give 14 day's notice of cancellation and provide a full refund.
